### TERMS AND CONDITIONS FOR "MAX2 TIMELESS AWARDS" MICROSITE CONTESTS

The following terms and conditions ("T&Cs"/ "Terms and Conditions") shall be applicable to Sony Pictures Networks India Pvt.
