Must fill the registration from online or by hand at Sir C.V.Raman Govt. I.T.I. Dheerpur Delhi-110009, on or before 26<sup>th</sup> June 2016, by 10:00 AM.
- 2. The Department/ Institute would not provide any facility / equipment to support for the contest.
- 3. The participants will have to shoot the photograph according to any of the two themesgiven on the spot.
- 4. Each participant will be required to submit only one photograph per theme.
- 5. The Photograph should be in JPEG format only. It is up to the participant to choose the photograph he/she wishes to use at the time of submission.
- 6. The Department/ Institute shall not be liable for any error / lapse / slippage in uploading any photograph for the Photo contest.
- 7. The photographs should only be taken by Digital SLR or point and shoot digital cameras. Photography by Cellphones/smart phone are not allowed.
- 8. Both Color and / or black-and-white photographs are accepted in the Photo contest.
- 9. No in camera or computer editing is allowed for the entry photograph.
- 10. Objects should not be added or removed in order to enhance the shot.
- 11. No composite images shall be accepted in the Photo contest.
- 12. In order to be eligible for the Photo contest, the photograph taken should be digital and capable of being transferred to a computer. The Institute shall not be responsible for any compatibility issues that may arise with such photograph. It is the responsibility of the candidate to bring appropriate DATA CABLE suitable for their Camera, so that the file/ Picture may be transferred to the computer etc.
- 13. Anymanipulated found during the contest, the entry would be disqualified from any prizes/awards in the competition.
- 14. The true representation of what was captured at the time of the picture shot being taken must be maintained. Compositing and multiple exposures are not allowed. Sandwich shots, double exposure, Photographs which consist in any way of more than one separate image or which has been manipulated are not eligible.
- 15. All photographs will be judged on the basis of relevance to the theme, composition, sensitivity, creativity and style.
- 16. No responsibility is accepted for ineligible entries or entries made fraudulently.
- 17. Any direct or indirect cost / expenses incurred by the registered participants towards taking the photograph and participating in the Photo contest shall be borne solely by the registered participant (including the cost of travelling / visiting the venue) and The Department/ Institute shall not be responsible for the same.

### BRIEF ABOUT DIGITAL PHOTOGRAPHY & INDUSTRIAL TRAINING INSTITUTES IN DELHI

Skills and knowledge are the driving forces of economic growth and social development of any country. The economy becomes more productive, innovative and competitive through the existence of more skilled human potential.

The Industrial Training Institutes play a vital role in economy of the country especially in terms of providing skilled manpower. At present there are a total 18 (Eighteen) numbers of Government Industrial Training Institutes with 10,035 seats in Delhi under the Department of Training & Technical Education, Govt. of NCT of Delhi. Training is imparted in 49 trades (Engineering+ Non-Engineering) different trades affiliated with National Council for Vocational Training (NCVT) or State Council for Vocational Training (SCVT) of duration 1-2 years.

The Digital Photography Trade is running in this institute under the NCVT Pattern with One year (Two semesters) duration with the Entry Qualification: Passed 10th Class examination and the trainees are

- a) Obtaining the training for
  - i. Handling of digital video cameras, Tape, DVD, HDD and accessories
  - ii. Lighting of different areas of video shooting. Practice on three point lighting, indoor and outdoor lighting etc. Practice on hard & soft, bounce, silhouette lighting, key lighting. Use of reflectors & skimmers.
  - iii. Using of microphones. Audio video recording, mixing, editing, dubbing of sound.
  - iv. Idea & planning of production proposal, scope, script, shot division, visualization according to script.
  - v. Shooting and editing of short documentary, news items, interviews, music video etc.
- b) The trainees of this trade can work as Commercial Artists/ Visualizers in advertising agencies or in government organizations, as an Artist with a publishing/newspaper house. They can also work as Graphic Designer in TV and film industry and as an Artist in the computer field.
