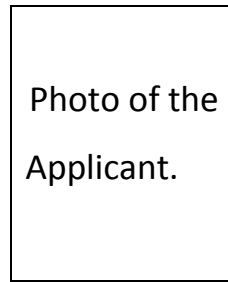
#### **Terms and conditions of application:**

2. There shall be no limit of the photographs to be sent on each subject.
3. Once submitted, these photographs shall be the property of the State Government which may decide to be used them the way it deems fit. The sender shall have no right on these photographs.
4. The photographs entered in the contest should be in high resolution and technically sound with caption mentioned below.
5. Age and nationality are no bar for participation but the photographs should be related to Haryana.
6. All photographs should be signed by the sender and these should be of the size of 12"x15".
7. The photographs so sent should be of high resolved along with CD (Jpg file) and should also be sent on email [hrphotocompetition2016@gmail.com](mailto:hrphotocompetition2016@gmail.com).
8. The photographs must be clicked by the applicant himself and these must not have been be published and displayed earlier.

All entries on the prescribed form along with photographs should reach Samvad Office SCO No.23, Sector 7-C, Madhya Marg, Chandigarh by 3.00 p.m on 31.7.16. Entries received after the stated time and day shall not be entertained.
