## **Eligibility Regulations**

1. All short films (Analog / Digital format) with a running duration of maximum 15 minutes are eligible for the competition.
2. Entries of all short films shall be accepted only in DVD format.
3. If language of the film is other than Malayalam and English, it must be dubbed or sub-titled in English.
4. Films may be entered by any Individual, Organization or Agency.
5. Selection of films will be done by a committee whose decision will be final. However, Time Ads Authorities reserve the right to accept or reject any film that is likely to offend sentiments, feelings or sensibilities of any caste, community, religion and sex or is likely to promote racism or ill will in the society.
6. A complete screening schedule of selected films shall be put up on Time Ads website.
7. Transportation and insurance costs of DVDs, related documents, photographs and publicity materials, if any shall be borne by the applicant.
8. Time Ads Short Film Competition Authorities would be allowed to use all photographs and publicity materials received along with the Entry and the same will not be returned to the entrants.
9. Time Ads Entertainment will hold the sole right to publish / telecast the short films in our website or any related events.
10. Censorship will not be applicable to any Short films entered in the festival.
11. For promotional / publicity purposes, excerpts from any short film entered in the competition may be shown on any Television network / Internet or related media during the competition period.
12. Entry Forms with incorrect / inadequate / illegible / ambiguous particulars will not be considered.
13. DVDs submitted for selection will be considered as final and no changes will be entertained after submission. It is the sole responsibility of the applicant to submit DVDs without any physical / quality defects.
14. All shortlisted entries will receive a certificate.
15. Films once selected and submitted for the final screening will not be allowed to be withdrawn under any circumstances, until the Competition is over.
16. Decisions of the Competition Authorities regarding all matters not expressly provided for in these regulations or which require interpretation of the clauses mentioned above shall be final and binding on all parties.
