## Notice of Logo Design Competition for IISER Berhampur

The Indian Institute of Science Education and Research Berhampur calls for a design competition for development of its Institute Logo for the development of identity and branding, capturing and promoting the main value/s of the organization. Accordingly all are hereby invited to participate in the competition for design of the Institute Logo.

#### Introduction and Background

The Ministry of Human Resource Development (MHRD), Government of India, announced the establishment of Indian Institute of Science Education and Research (IISER) Berhampur for the academic session 2016-17 to promote quality education and cutting edge research in basic sciences and to provide a platform for the Faculty to engage in high-quality education, at undergraduate and postgraduate levels.

Recently, the Government of India notified ex-post facto approval for the establishment and operationalization of new Indian Institute of Science Education and Research at Berhampur. The Union Cabinet approved the setting up of IISER Berhampur at the transit / temporary campus at the academic-cum-workshop building of the Government ITI, Berhampur. The student strength intake for the academic year 2016-17 in the BS-MS course is 60 which will progressively go up and the cumulative student strength is envisaged as 665 in the 3rd year, including MS Degree, MS-Ph.D., Ph.D. and Postdoctoral Fellowships. The total cost of the project for the temporary campus is Rs. 152.79 crores. Ed.CIL, a PSU of Ministry of HRD, the Government of India has been asked to submit a proposal for preparation of a Detailed Project Report for the permanent campuses. Thereafter the process for setting up of the campus would start.

The IISER Bhopal has been vested with the responsibilities of mentoring IISER Berhampur by MHRD.

The Indian Institutes of Science Education and Research (IISERs) were created in 2006 through a proclamation of Ministry of Human Resource Development, Government of India, to promote quality education and research in basic sciences. Soon after the announcement, two of these Institutes at Pune and Kolkata, respectively, were started in 2006. This was followed by an Institute at Mohali (2007) and at Bhopal, Trivandrum in 2008 and Tirupati in 2015. Each IISER is a degree-granting autonomous institution with a prime focus to integrate science education and research, with a motive of attracting bright students and world-class faculty.

Indian Institute of Science Education and Research Berhampur will provide a platform for the faculty to engage in high-quality pedagogy, at both undergraduate and postgraduate levels, and to perform cutting edge research in frontier areas of basic sciences. The Institute is also committed to impart high moral and ethical values to students and create a genuine concern for social and environmental issues. With these set of broad objectives, it is believed that IISER Berhampur aims at emerging as a world-class Institute in the frontier areas of science.

#### **Terms and Conditions:**

- 1. All entries must be submitted through the post in hard/soft copy (CD). Entries submitted through any other medium/ mode will not be entertained.
- 2. The Competition is open to all citizens. The entry could be an individual project or a team project.
- 3. The winning design of the logo would be the intellectual property of the IISER Berhampur and the winner cannot exercise any right over it, after acceptance of the prize. The prize-winning logo is meant to be used by IISER Berhampur for promotional and display purposes and also for any other use as may be deemed appropriate for the initiative. The winning entry will be awarded a prize money of Rs. 51,000/- and a Certificate.
- 4. The logo must not contain any provocative, objectionable or inappropriate content.
- 5. The logo designed by a participant must be original work and shall not be an infringement of Intellectual Property Rights.
- 6. Only one entry per participant would be considered.
- 7. The participant is required to submit an affidavit on Stamp Paper of Rs. 100/- duly attested by first class Magistrate/Notary/Oath Commissioner showing therein full details of father's/husband's name along with the residential address. The affidavit shall also show that the logo designed is original work and does not violate any provision of any Intellectual Property Laws in India. IISER Berhampur does not bear any responsibility for any violations or infringements of intellectual property carried out by the participants. The affidavit must be submitted in original to this Institute along with the application.

- 2. IISER Berhampur reserves the right to cancel or amend all or any part of the Contest and/or the Terms & Conditions/Technical Parameters/Evaluation Criteria. However, any changes to the Terms & Conditions/Technical Parameters/Evaluation Criteria, or

cancellation of the Contest, will be updated/posted on the Institute website i.e. www.iiserbpr.ac.in. It would be the responsibility of the participants to remain informed about any changes in the Terms & Conditions/Technical Parameters/Evaluation Criteria stated for this Contest.

3. The responsibility to comply with the guidelines and other conditions lies fully with the participant and the Government of India shall not be liable for any dispute raised by a third party.

#### **Technical Parameters**

- 1. Participants shall send the soft copy of logo in CD/DVD in JPEG/PNG/PDF/ PSD/ CDR format only.
- 2. The logo should be in high resolution with minimum 300 DPI.
- 3. The logo should be designed on a digital platform, which shall be in an editable and open file format.
- 4. A specification sheet containing graphical construction of the design in exact proportions in a bigger size, along with final design, theme synopsis and concept is required to be submitted. All technical details, including file formats, can be structured in the sheet itself.
- 5. The logo should be usable on the website/social media such as Twitter/Facebook and on printed material such as black and white press releases, stationery and signage.
- 6. Participants should not imprint or watermark logo design.
- 7. The Logo should be designed in colour.

#### **Evaluation Criteria**

- 1. All the entries received by IISER Berhampur would be assessed by a Selection Committee for final evaluation.
- 2. Entries would be judged on the basis of elements of creativity, originality, composition, technical excellence, simplicity, artistic merit, visual impact and its relevance to the core functions of Basic Sciences.
- 3. The decision of the Selection Committee would be final and binding on all the contestants and no clarifications would be issued to any participants for any of their decisions.
- 4. The disqualified entries shall not be used by the IISER Berhampur for any purpose and IISER Berhampur shall have no intellectual rights over the same. Further, they will not be returned to the participants and shall be destroyed within 3 (three) months period. The unsuccessful entries can be re-used by the participating competitors for any successive bids/ competitions without any prejudice attached to it.

Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to the local jurisdiction of Berhampur, Odisha State.
