You agree to waive any moral rights that may exist in relation to your contribution. You acknowledge that you understand the style, nature and format of the Programme and that we reserve the right to show all auditions whether successful or unsuccessful.
13. Should you be selected to take part in the Programme you agree and undertake to enter into further contracts with Arré and you agree to abide by the terms therein.

14. All personal details and/or information given in your application either in this form or otherwise must be truthful, accurate and in no way misleading.

15. Arré reserves the right to disqualify you if you have supplied untruthful, inaccurate or misleading personal details and/or information, have failed to abide by the Rules and/or are in breach of these terms and conditions.
