TERMS AND CONDITIONS

A. ABOUT THE CONTEST AND HOW TO PARTICIPATE

Win OPPO contest (hereinafter referred to as "<u>Contest</u>") is hosted by Sony Pictures Networks India Pvt. Ltd. and/or its affiliates ("<u>SPN</u>") in relation to broadcast of Australian Open 2016 on its sports channel(s) ("<u>Channels</u>") as per the terms and conditions stated hereunder (<u>"Terms and Conditions"</u>):

The Contest will be in relation to broadcast of Australian Open 2016 matches (each match an "Event") and shall continue from January 18, 2016 to January 31, 2016 ("Period"). SPN shall select one (1) Participant ("<u>Winner</u>") from the Participants providing correct answers for applicable question and the selection shall be made on a random selection basis from the list of correct Entry providers. The Winner shall be announced via the Platform and/or such additional mode of communication as deemed appropriate by SPN. Winner shall be announced on the day following the day when relevant question was asked during live broadcast. A Contest Participant stands chance of winning only once in the Contest. Any subsequent wins (if declared) will be automatically void. Each Winner will be given one (1) OPPO branded mobile phone subject to satisfaction of the Terms and Conditions ("<u>Prize</u>").

- 9. The Participant(s) represents and warrants that the Entries is an original work of the Participant and the Participant has all necessary rights, licenses, consents and permissions to use, and to authorize SPN to use, any and all copyrights, or other intellectual property rights in and to Entries in order for SPN to use the Entries on any of its platform or otherwise. The Participant specifically acknowledges and agrees that SPN shall have complete rights and title over Participant's Entr(ies) and shall be free to exploit it in any manner and on any platform it may deem appropriate for perpetuity.
- **10.** In the event of any discrepancy as to the date and/or the time of receipt of an Entri(es), SPN shall have the final decision in resolving such discrepancy.

C. ELIGIBILITY FOR PARTICIPATION IN THE CONTEST

11. The Contest is open for residents of India only who access to the Website page of the channel/channel website from India IP address. For purposes of clarity, an Indian resident accessing the Website page of the channel/channel website from a foreign IP address may not be able to participate due to the contest being geo blocked outside India.

- **12.** Non-resident Indians are not eligible for participation in the contest even if they participate by accessing to the Website page of the channel/channel website from India IP address.
- 13. This Contest is strictly governed by the laws of India including the Privacy Laws of India
- **14.** The participants must have attained the age of 18 years to participate in the Contest.
- **15.** Employees, agents and promoters (including their immediate family members) of SPN and any of their divisions, affiliates and subsidiaries, and others associated with the Contest in any manner, are not eligible to participate in the Contest.
- **16.** Participants shall ensure that all their Entries shall be in compliance to usage rules of Twitter.

D. TERMS AND CONDITIONS TO CLAIM THE PRIZE

The Participant specifically agrees not to file in person/through any family member and/or any third party any applications, criminal and/or civil proceedings in any courts or forum in India against SPN and/or their directors, employees, officers, affiliates or subsidiaries to claim any damages or relief in connection with the Contest.
