## **#T20onAirtel4G Contest: Terms and Conditions**

- 1. Under the #T20onAirtel4G contest, Airtel Customers in India are encouraged to share their selfies along with their Airtel 4G Sim. Selfies should be shared with Airtel India to be eligible to win an iPhone 8.
- 2. Users must share selfies of themselves and upload them on their handle on Instagram or on their wall on Facebook as public post or on their Twitter handles and tag @AirtelIndia with hashtag #T20onAirtel4G. User must also tag two of their friends.
- 3. All participants must have a valid and an active Airtel 4G connection to participate in the contest ('Eligible Customer').
- 4. Pictures being uploaded by the Eligible Customers shall be judged based on aesthetic value of the selfie, clarity of Airtel 4G sim in their selfies and number activation.
