TERMS & CONDITIONS

Spot The Imaginary Friend Contest ("Contest")

 - a. have a valid proof Indian citizenship;

 - d. Shall be of age between 4 years to 17 Years

- 48. No waiver of any rights by the Organizer will be taken as a waiver of any other rights it may have. For instance, if the Organizer waives its right to object to a particular breach of these terms and conditions by a Participant/Winner, it does not prevent the Organizer from objecting to any other breaches by that Participant/Winner and/or or any other /Participant/Winner.
- 49. The Contest shall be subject to the exclusive jurisdiction of competent Courts at Mumbai and the law applicable shall be Indian Law.
